7. Conduct

7.1 All participants in Just a walk to the beach are required to conduct themselves in an appropriate manner.

8. The Just a walk to the beach core team

8.1 Catherine Curtis will act as Secretary and Treasurer and will be responsible for the general administration.

8.2 Douglas Battam will act as Chairman and co treasurer.

8.3 Robert Curtis is the primary event organiser.

8.4 In the event of any resignation, another person will be co-opted by the remaining two committee members

9. Finance

9.1 The bank account is held in the name of 'Just a walk to the beach' and is held by Catherine Curtis and Douglas Battam.

9.2 'Just a walk to the beach' will pay no expenses from monetary donations or sponsorship money.

9.3 No expenses will be paid to participants.

9.4 Funds will be held until 1st November in a community account.

9.5 Donations towards organising the event (ie cost of event t shirts) will be accepted but clearly recorded and kept separate from funds raised.

9.6 Accounts will be kept and be available for scrutiny on request.

13. The Events (2008)

13.1 Challenge 1: 'Just a walk to the beach'

To get from your doorstep to Saunton Sands in North Devon by any means possible without using an engine. You must carry with you something to catch a wave with and get sponsored.

13.2 Challenge 2: 'Just swim to the beach'

Swim your miles in your local pool. Calculate how many miles it is from your house to the beach take the number of miles and turn them into lengths (e.g. 400 miles becomes 400 lengths) work out the time period over which you will complete the lengths and get sponsored.

13.3 Challenge 3: 'Just a walk ON the beach'

A circular walk (about 10 kilometres) from Saunton Sands car park along the Southwest Coastal path around 'the Neck' and back along the beach. Get sponsored or make a donation.
